2. Objections received from certain Assistants Grade-III.

In the reference 1st read above, tentative seniority list of Assistant Grade -III in terms of APSCSCL Recruitment and Service Regulations and as per the roster and rule of reservation was communicated to all the individuals shown in Annexure enclosed, calling for objections, if any, with due supporting evidence/documents. Accordingly, following objections were received.

1. Sri Khaja Masood Ali, Asst.Gr-III, DMO, Mahabubnagar:

The individual has raised objection that his date of joining in the cadre of Asst.Gr-III is wrongly shown as 07.11.1995 instead of 08.10.1982 and requested to correct the same.

It is to inform that, services of the individual were regularized in the Corporation as Asst.Gr-III w.e.f.07.11.1995 as per G.O.Ms.No.466 Food & Civil Supplies (III) Dept., Dt.7.11.1995. His request for regularization of services w.e.f. 8.10.1982 was not considered, as the issue is pending in Hon'ble High Court in W.P.No.18717 of 2004 filed by the individual. Hence the objection of the individual is devoid of merit.

2. B.Laxman, Asst.Gr-III, DMO, Mahabubnagar:

The objection of the individual is that, he got promoted to the cadre of Asst.Gr-III vide Procdgs.No.P.Admn.A3/1571/2011-6, dt.3.8.2011 and reported on 12.08.2011, but his name is not included in the tentative seniority list communicated.

As the individual is already promoted to the cadre of Asst.Gr-II vide VC&MD Procdgs. Dt.07.1.2014, his name will be added to the final seniority list of Asst.Gr-II.

3. Kum. P.Kusuma Kumari, Asst.Gr-III, DMO, Srikakulam:

The objection of the individual is on caste mentioned in the tentative seniority list, and requested to rectify her caste as BC-A instead of OC.

Roster points are categorized as SC, ST & OC only, and all the backward classes come under the category of OC only. Thus, the caste of the said individual mentioned in the tentative seniority list is as per the roster point classification, as such though she belongs to BC-A, her category was mentioned as OC. Hence, her objection is not considered.

4. Sri K.Janardhan, Asst.Gr-III, DMO, Kurnool:

The objection of the individual is that, though he got promoted as Asst.Gr-III vide Procdgs.No.P.Admn.A2/143(51)/2011-4, dt.10.6.2011 and reported on 20.07.2011, his name is not included in the tentative seniority list.

As the individual is already promoted to the cadre of Asst.Gr-II vide VC&MD Procdgs. Dt.7.1.2014, his name will be added to the final seniority list of Asst.Gr-II.

5. Sri I.V.Ramana, Asst.Gr-III, DMO, Guntur:

The objection of the individual is that, though he got promoted to the cadre of Asst.Gr-III vide procdgs.No.P.Admn.A3/1571/2011-1 and reported on 20.06.2011, his name is not included in the tentative seniority list communicated.

As the individual is already promoted to the cadre of Asst.Gr-II vide VC&MD Procdgs. Dt.7.1.2014, his name will be added to the final seniority list of Asst.Gr-II.

6. Sri B.Kiran, Asst.Gr-III, PDS Section, Head Office:

The objection of the individual is that, he was appointed as Asst.Gr-III on compassionate grounds and joined the Corporation on 04.02.2011, but his name is not included in the tentative seniority list communicated. He also requested to consider to grant him promotion as Asst.Gr-II, as he has completed probation period by Feb, 2013 itself.

The tentative seniority list was communicated on 01.7.2013 by which time his probation was not declared. Since his probation is now declared and as the individual is already promoted to the cadre of Asst.Gr-II vide VC&MD Procdgs., dated.07.1.2014, his name will be added to the final seniority list of Asst.Gr-II at appropriate place.

7. Sri R.Kesava Kumar, Asst.Gr-III, DMO, Mahabubnagar:

The objection of the individual is that, vide H.O.Circular no.P.Admn.64(58)/90, dt.3.3.1990, his seniority was fixed at sl.no.18 in the cadre of Assistant Grade-III. He was suspended in ACB trap case up to 15.01.2003. Further, he was dismissed from Corporation service on 16.01.2003. Subsequently, as per the orders of Hon'ble High Court, he was reinstated into service w.e.f.07.12.2011 with all consequential benefits. While informing the above, the individual has requested to fix his seniority as per rules in force and include his name in the seniority list of Assistants Grade-III.

The individual was suspended in ACB case while working in DO, Mahabubnagar. Subsequently, he was dismissed from service on 16.1.2003. thus, his name was removed from rolls of the Corporation. He approached the Hon'ble High Court against dismissal order and finally got orders in his favour. In light of Hon'ble High Court orders, he was reinstated into service on 07.12.2011. The matter was referred to Government for clarification on regularization of his services, as such his name was not included in the tentative seniority list of Asst.Gr-III.

Now as the individual is already promoted to the cadre of Asst.Gr-II vide VC&MD Procdgs., dated.07.1.2014, his name will be added to the final seniority list of Asst.Gr-II.

Also, name of Sri K.Krishna, Asst.Gr-III, DO, Rangareddy was missed in the tentative seniority list communicated vide reference 1st cited. The same has now been included and with above mentioned modifications, final seniority list of Asst.Gr-III is prepared and communicated now (Annexure).

District Managers concerned are requested to communicate the said seniority list to the employees concerned working under their control. They are also requested to furnish the served copies of seniority list to Head Office immediately.
