WHEREAS, in the reference read above, tentative seniority list of Sr.Officer Gr.II in terms of APSCSCL Recruitment and service Regulations and as per the Roster and Rule of Reservation was communicated to all officers shown in Annexure enclosed therein calling for objections if any on the tentative seniority list communicated. Accordingly, certain objections have been received as detailed below:

WHEREAS, the following employees have raised objections on placement of employees belonging to SC/ST category before them who were promoted to the cadre of Sr.Officer Gr.II after their joining on promotion, in the tentative seniority list due to extending the benefit of roster point at the time of fixation of seniority.

1. Sri R.Y.Prabhu, D.M.Rangareddy
2. Sri J.Jayaram, Sr.Officer Gr.II.
3. Sri Y.V.Sambasiva Rao, D.M. Khammam.

WHEREAS, Government in G.O.Ms.No.2, Social Welfare (SW.ROR1) Dept., dated: 09.01.2004 have issued certain guidelines in implementing rule of reservation in promotions in respect of SC and STs. The said G.O., reads as:

**"Carry forward vacancies: Regarding carry forward of vacancies, if no qualified candidates are available, the following procedure shall be followed.**

***In case qualified Scheduled Caste/Scheduled Tribe candidates are not available for a particular panel year the vacancy shall be carried forward to the subsequent year. In the second year if Scheduled Caste/ Scheduled Tribe candidates are not available, the vacancies or points meant for Scheduled Caste/Scheduled Tribe candidates may be filled up by candidates from the feeder category based on merit and seniority. The number of such vacancies meant for Scheduled Caste and Scheduled Tribe should be carried forward and filled up first in the immediate subsequent year with Scheduled Caste/Scheduled Tribe candidates".***

WHEREAS, the Corporation is following rule of reservation in considering promotions from the year 2005 onwards and since there are carry forward vacancies belonging to SC/STs as per roster, the same are being filled-up with candidates belongs to SC/ST category from feeder cadres. Thus, the slots allotted to SC/STs in roster, were filled with SC/ST candidates. Based on the slots given to employees belonging to SC/STs as per rule of reservation, the said seniority list was prepared and communicated, which does not effect the panel of particular category while considering promotions as the promotions are being effected as per eligibility of employees in their present cadre. Hence objections of the officers mentioned at Sl.No. 1 to 3 merits no consideration.

WHEREAS Sri K.Rama Rao, Sr.Officer Gr.II has raised objection that his seniority is fixed at Sl.No.22, whereas the name of Sri V.Venkata Ramana was shown at Sl.No.1. He stated that both of them belong to the same ST category and as of now they are the only ST Officers available in the cadre of Sr.Officer Gr.II, as such requested to place him at proper place.

WHEREAS, Sri V.Venkata Ramana has been promoted earlier than Sri K.Rama Rao and his panel precedes that of Sri K.Rama Rao and he was placed in the available roster point as on the date of promotion. Sri K.Rama Rao, figured in the next panel of Junior Officers and hence placed after Sri V.Venkata Ramana.

WHEREAS, though Sri K.Rama Rao, is one of the two ST Sr.Officers Gr.II available in the Corporation, he was promoted to the cadre of Sr.Officer Gr.II three months after promotion of Sri V.Venkata Ramana. Accordingly, Sri K.Rama Rao Sr.Officer Gr.II was placed in the tentative seniority list after Sri V.Venkata Ramana. As such, there is no merit in the objection filed by Sri K.Rama Rao, Z.M. Nalgonda.

WHEREAS, names of certain officers promoted to the cadre of Sr.Officer Gr.II after communication of tentative seniority list have been included at appropriate place as per roster and names of officers promoted to the higher cadre or retired/expired have been removed in the final list.

AND WHEREAS, after taking into consideration, the objections and modifications made in the tentative seniority list, the final seniority list of Sr.Officer Gr.II in terms of APSCSCL Recruitment & Service Regulations and as per Roster & Rule of Reservation is hereby communicated.

The General Managers/District Managers/Zonal Managers concerned are requested to communicate the said seniority list to the officers concerned and furnish the served copies of seniority list to Head Office immediately.
