Reorganization Act 2014 - Joint Action Committee of both AP and Telangana Employees of Civil Supplies Corporation Ltd., - Requested for transfer of services of employees of the Corporation between the two States of Andhra Pradesh and Telangana based on Board Resolution dated.27.08.2015 subject to final bifurcation of employees as per Section 82 of Re-Organisation Act - Considered - Orders - Issued.

In the reference first cited, Government of India issued Notification of bifurcation of Andhra Pradesh into Andhra Pradesh and Telangana States with effect from 02.06.2014. As per Section 82 of the Act on provision of employees of Public Sector Undertakings "on from the appointed day, the employees of State Public Sector Undertakings, Corporations and other autonomous bodies shall continue to function in such undertaking, Corporation or autonomous bodies for a period of one year and during this period the Corporate body concerned shall determine the modalities for distributing personnel between two successor states".

Government in General Administration (SR) Department vide Circular Memo No.,13257/SR/A1/2014, dated.20.05.2014 have issued guidelines for provisional allocation of posts between the two states i.e. AP and Telangana. Subsequently, Government in Industries & Commerce (SRC) Department vide Circular Memo No.3685/INF (SRC)/2014, dated.29.05.2014 have issued further guidelines on apportionment of assets , liabilities and demerger of Ninth Schedule entities. Wherein, while mentioning the Section - 82 of the AP Re-organisation Act, 2014, Government have requested all the ninth Schedule entities to wait for guidelines to be announced and in the meantime provisional division and allocation of staff may be made as per the operational division Organogram and any other guidelines issued by the State Government in this regard as the main intention would be to ensure that delivery of services is not affected.

In view of the above guidelines received from the Government, all regular sanctioned and available posts in each cadre in the united APSCSCL have been divided in the ratio of 41.68 and 58.32 between the States of Telangana and Andhra Pradesh respectively at Head Office level based on Bio-data of the employees which was already prepared as per record and the employees belong to both AP and Telangana were provisionally allocated to work in Head Office of the two Units of the Corporation i.e. AP and Telangana Units on administrative needs duly following the guidelines issued by the Government . Employees working in Districts are as it is under the control of concerned units of AP and Telangana (i.e 13 Districts under AP and 10 Districts under TS) like all other Govt. Departments.

After following AP Re-Organisation Act, 2014 and subsequent guidelines and considering the requests made by Employees Associations of AP and Telanagana Units, statements showing the (1) Division of total cadre strength of the Corporation (sanctioned and vacant posts) between the AP and TS in the ratio of 58.32:41.68, (2) Division of 62 vacancies (earmarked for SC/ST employees) as on 01.06.2014 between the AP and TS in the ratio of 58.32:41.68 and (3) Final Allocation of employees of the Corporation available as on 01.06.2014 between the AP and TS were got approved by Managing Directors of both Andhra Pradesh and Telangana Units and were placed before the Board as a Circulation Item on 27.08.2015 for its approval of Final Allocation of employees of the Corporation between the AP and TS .

The Board vide Circulation Item, dt.27.08.2015 has resolved to approve the division of the cadre strength of the Corporation (sanctioned and vacant posts) between the successor states of Andhra Pradesh and Telangana in the population ratio (58.32 and 41.68) along with the division of vacancies (earmarked for SC/ST employees as on 01.06.2014) and also final allocation of the employees available as on 01.06.2014 between both the successor states under the provisions of Section 82 of the Andhra Pradesh Re-organization Act, 2014 . Further, Board has authorized the Managing Director of APSCSCL to take necessary further action in the matter. The above said resolution has been taken note by the Board in its 189th meeting held on 09.12.2015.

Meanwhile, Chief Secretary, Govt. of Andhra Pradesh, General Administration (SR) Dept., vide Letter No.2394/GAD/SR/2015-4, dated.27.08.2014 requested all Secretaries/Prl. Secretaries/Spl. C.S. to Govt., AP, Secretariat, Hyderabad to return all the demerger recommendations to the Expert Committee with a request to finalise and send along with the recommendation on division of employees between the two States. Further, through DO letters dated 11.8.2015 and 25.8.2015 the Chief Secretary, Govt. of AP has requested the expert committee that liability in its meaning includes employees and while apportioning assets and liabilities, employees too have to be distributed and distribution of employees cannot be delinked from apportionment of Assets and Liabilities. He has also informed that the Govt. of AP will not have any objection to allocation of employees of Schedule-IX Institutions based on population ratio by the Expert Committee, It was further requested not to proceed with division of Assets and Liabilities if it is not possible to take up allocation of employees also.

In view of the above directions of Govt. of AP, orders on final bifurcation of employees of Civil Supplies Corporation between the States of AP and Telangana has not been issued.

Whereas Joint Action Committee of both AP and Telangana employees Unions/Associations of Civil Supplies Corporation Ltd., have requested the Government, Commissioner of Civil Supplies, AP and VC & Managing Director of A. P. State Civil Supplies Corporation Ltd., to take action for transferring the services of employees of the Corporation to the successor states i.e., AP and Telangana based on resolution passed by the Board on 27.08.2015 subject to final bifurcation of employees of Civil Supplies Corporation as per Section 82 of AP Re-Organisation Act, 2014.

The matter has been examined in detail by VC&MD, APSCSCL and CCS & Managing Director, TSCSCL and it has been decided to transfer the services of employees of Civil Supplies Corporation available as on 01.06.2014 between the successor States i.e. Andhra Pradesh and Telangana basing on resolution passed by the Board on 27.08.2015 as a temporary arrangement till the final bifurcation of employees of Civil Supplies Corporation is completed.

In view of the above, services of employees including retired officers/staff (during the period from June'2014 to October'2015) mentioned in Annexure enclosed along with this proceedings are hereby transferred to the units in their respective States as indicated against their names based on resolution passed by the Board on 27.08.2015 subject to final bifurcation of employees of Civil Supplies Corporation as per Section 82 of AP Re-Organisation Act, 2014 and approval of demerger plan of the Corporation. They are directed to report before concerned Head of the Organisation by 04.01.2016 so as to issue posting orders to them in their respective Units.

The concerned Functional Managers at Head Office of both AP and Telangana Units and District Managers/Zonal Managers of APSCSCL and TSCSCL are directed to relieve the employees working under their control whose services have been ordered to transfer, immediately so as to enable them to report in their respective Head of the Organisations.
